When you call LexCall 3-1-1 during office hours (Mon-Fri, 7AM - 8PM) you will speak with a friendly person who will help you... not a recording. ### SIDEWALKS

A reminder to homeowners, you are responsible for the maintenance of the public sidewalks adjacent to your property.

According to the Lexington Code of Ordinances, replacement of the sidewalk is needed if:

- Vertical displacement is greater than one inch.
- Sidewalk is raised and has a slope of greater than one inch.
- Panels have cracked or broken material so that pieces of the sidewalk are missing or loose.
- A safety issue exists which is not defined by the previous criteria but which the inspector considers significant.

#### Repair of the sidewalk is needed if:

- Cracks with 1/8 inch or greater horizontal displacement.
- Vertical displacement less than or equal to one inch.
- Pop outs of holes.
- Panels have cracked or broken material, but where no pieces of the sidewalk are missing or loose.

Please Note: for residential homeowners only, grant money may be available to assist with making the needed repairs of sidewalks.

If you feel a sidewalk needs to be inspected, you may call LexCall (by dialing 311 or 425-CALL) and request an inspection of the sidewalk. If the Division of Code Enforcement marks the residential sidewalk for repairs, the owner occupant may be entitled to financial assistance. Funds are depleted rapidly, so reimbursement is given on a "first completed - first served" basis.
