## **New Business:**

- Election of Officers

- Lake
  - o Suggestions were offered for front of lake (i.e. fence, re-purpose stone from front entrance)
  - o Terri wants a document sent to all Homeowners about lake restrictions
  - o Patrick moved to have legal interpretation by a qualified real estate attorney of 1997 document clarifying what is an owner and who has access to the lake. Christine seconded the motion. Motion passed 4-1. Several board members requested that legal fees be for \$500 or less. No motion was made. Edwin did not think he could get a legal opinion for less than \$500.
- Street Trees
  - o Was advised that they can be found on the ARHOA website.
- Truck Traffic on AR Drive
  - o Still receiving some complaints but at this point there is nothing that can be done to enforce any restrictions as AR is a public street. Several board members continued to voice displeasure at the developer for breaking his promise of exiting out Brighton East onto Todd's Road.
- Bid was submitted for \$750 to remove trees from across creek behind Doe Meadow Court. The bid was rejected and Board Member Johnston advised he would remove the Tree(s) free to assist with the legal fees payment for the lake owner interpretation.
