Homeowners are encouraged to contact the police if you notice unusual activity in the area or on your property.

## **“LIMBING” UP!**

Homeowners are strongly encouraged to prune low-hanging branches from your street trees. In case you are not aware, the Lexington-Fayette Urban County Government requires homeowners to maintain their street trees.

Low-hanging tree limbs must be pruned to provide a minimum of seven feet of clearance over sidewalks and eight feet over streets. Limbs must not interfere with a driver's ability to see

street signs, such as speed limit and stop signs, especially at intersections.

This first photograph illustrates the right way to prune, so that proper clearance is provided for pedestrians who are walking on the sidewalk:




As you can see, Bob, who is over 6 feet tall, can walk under this tree without worrying about bumping his head.
